11 Inner South Community Committee Briefing Lettings Policy Review Consultation Update

The Area Leader, South Area Support Team submitted a report which updated the Committee on the latest information with regards to lettings policy review consultation. In February 2016, Executive Board agreed to commence consultation on these proposed changes to Housing Leeds' current lettings framework with a view to approving a revised policy in September/October 2016.

The consultation commenced with two Elected Member sessions in early March 2016. This has been followed by further consultation with local tenant and resident groups, statutory and voluntary sector partners and individual tenants and residents.

The paper provided an update on progress with the consultation to date, and some feedback on the key themes to emerge so far.

The report set out the proposals being consulted on to the council's lettings, including the development of a tenant transfer list, a review of the lettings policy and a new approach to community lettings policies.

The report set out the proposed consultation process and timescales for implementation of the new policies.

Members raised concern about people coming into the area and being placed higher on waiting lists than local people already looking for accommodation.

Members sought clarification on whether people already living in South Leeds would be prioritised and requested a separate meeting to identify and address concerns.

Members also discussed the statistical information available on people living in Inner South for example how many people live in Inner South and how many lived in flats.

RESOLVED The Committee resolved to:

- (a) Note the contents of the report; and
- (b) Request a meeting to take place with all members of the Inner South Committee to be invited, with the relevant council officers, to identify and address concerns.

12 Inner South Community Committee Briefing Neighbourhood Teams - June 2016

The Area Leader South Area Support Team submitted a report which highlighted steps taken to provide an integrated service for District Nursing,

Community Matrons, Intermediate Care Services and area-based Social Work which formerly operated to geographical populations with therapy services spread across intermediate care and domiciliary physiotherapy.

Caroline McNamara Clinical Lead for Adult Services Leeds Community Healthcare NHS Trust - Leeds Community Healthcare NHS Trust; Sam Walton – Adult Social Care were in attendance to answer Members' questions.

Members discussed the issue of mental health in the Inner South area. Members also discussed what more could be done to address mental health problems and considered that more collaborative working with the NHS was a good way forward.

The role of GPs surgeries in reducing health inequalities was discussed and it was highlighted that some small GP's surgeries lack the resources and services of the larger practices. Members felt that further work was needed to make small surgeries aware of increased collaborative working in areas like social prescribing. Rachel Brighton, Public Health advised that some work is taking place in this area and she would look to provide an update on social prescribing referrals.

- (b) Request an update report on social prescribing referrals made in the area, particularly through GP's.

13 Inner South Community Committee Update Report

Leeds Transport Conversation

Purpose of report

 To report on the Transport Conversation and engagement process and seek feedback and input from Members on the future strategic approach to transport in the city and the development of a proposition and delivery plan for the £173.5 million fund due to be allocated following the cancellation of the NGT project.

Main issues

- 2. Transport is a fundamental component of what makes a prosperous and liveable city. Our vision is for Leeds to be a compassionate, caring city with a transport system that helps all our residents benefit from the city's economic growth. Getting our transport system right is a critical element of achieving the Council's Best City ambition.
- 3. Following the NGT Public Inquiry in 2014, the Department of Transport (DfT) announced (12th May 2016) that the Transport and Works Act Order (TWAO) powers for the New Generation Transport (NGT), would not be granted. However, at the same time the Secretary of State committed to making available to the city the £173.5m funding previously allocated to the NGT scheme, would be available for alternative public transport improvements in Leeds.
- 4. A letter was received from the DfT (23.06.16) confirming funding for public transport improvements stating that

"The £173.5 million has been retained for Leeds because of the well-rehearsed and long standing need for significant public transport improvements in the city, particularly in the absence of a rapid transit system along the lines previously envisaged. This does not have to be a like for like alternative to the NGT scheme, a programme of smaller coordinated interventions may deliver change in a more realistic and publicly acceptable way."

5. In response to the NGT decision, the Leader of the Council initiated a city wide debate on the future transport strategy which was launched with a Transport Summit (10th June 2016). The Summit was attended by over 170 stakeholders from across the city who contributed to a discussion on the city's transport ambitions. At the Summit, the Leader announced the start of the City's largest ever Transport conversation seeking views from key stakeholders, partners and most importantly, communities from across the city. Councilor Blake said;

"A city as diverse and geographically large as Leeds has many different needs, so we are encouraging as many people as possible to let us know their stories and put forward their ideas."

- 6. The first phase of the "Transport conversation" was launched by an on-line survey on the 2ND August www.leeds.gov.uk/TransportConversationSurvey and will close on the 20th September. Paper copies will be made available at Hubs, One stop centres and Branch Libraries along with being sent directly to access group members without online access. The online survey has been circulated to a wide range of networks across the city and includes the following communication activities and events.
- 7. These Channels include the distribution of 10,000 Postcards, advertising the questionnaire at events such as City Connect, South Bank Consultation. With Posters, postcards and paper copies available at the Community Hubs and One stops Branch Libraries Housing offices and arts centres. There is to be a wide range of marketing employed including advertising on the radio, on bus rears and sides, advertising at various rail sites, social media and press releases.
- 8. Following on from the Transport Summit workshop, there will be two further workshops arranged for the 15th and 20th September 2016, with additional workshops and presentations with key stakeholders, as well as one to ones with Operators, Business, Special interest User Groups, Access and equality groups. The Transport Conversation is also working alongside the West Yorkshire Combined Authority (WYCA) and partners along with the setting up of an Independent Panel of experts to help inform the programme.
- 9. These activities and feedback will inform the development of a wider set of strategic principles on which further conversations with the city will continue before finalising the long-term strategy at Executive Board sometime next year (Spring/Summer 2017).
- 10. Additionally the Transport Conversation feedback will be fed into the development of an outline series of proposals for spend of the £173.5m, culminating in a report to Executive Board currently planned for the 19th October 2016 meeting. The rational for an early submission is to gain the certainty and commitment needed to allow the development and progression of detailed planning and proposals by securing early government sign-off for the £173.5m earmarked for Leeds. Subject to approval by Executive Board, it is anticipated that a formal case will be submitted before the end of autumn 2016. And so a first phase of consultation along with an early Executive Board report is required in the context of the development of a longer term strategy.

- 11. Alongside this conversation the West Yorkshire Combined Authority (WYCA) are currently undertaking consultation on a new West Yorkshire Transport Strategy and Bus Strategy which includes a series of 23 drop in events across Leeds. The feedback received will be used by WYCA to develop a new, 20-year West Yorkshire Bus and Transport strategies. A team from the Combined Authority, along with representatives from bus operators, will be on hand at each event to answer questions and help people take part. Officers from the Council's Highways and Transportation service will be supporting WYCA colleagues at the events.
- 12. This work will complement and develop the work set out in the 21st Century Leeds Transport Strategy Executive Board Report.

Options

- 13. An Executive Board report in October 2015 set out how Leeds provides a strong historical illustration of how major investment in transport infrastructure has resulted in transformational economic growth from the Leeds Liverpool Canal, to the Victorians who cemented the city's position on the railway network, to our emergence as a 'motorway city' in the 1970's. Today, Leeds is following the global trend towards highly skilled jobs clustering in a compact environment. If this growth is to continue, people need to be able to easily access a denser and more productive city centre.
- 14. With additional car demand come additional issues to resolve, for example road causalities, poor air quality, noise, carbon, congestion. Our centres can be car dominated in places whereas we want public spaces which are more people friendly. To tackle these issues and grow our city sustainably, we need more people travelling by sustainable modes.
- 15. The ambition is to have a transport system that supports the growth of our economy, creates a place people want to live and work, that everyone can access, that has a positive effect on people's health and wellbeing and is less harmful on the environment.
- 16. The Council with the West Yorkshire Combined Authority (WYCA) and partners are already delivering significant improvements to transport in Leeds to help deliver these ambitions. The Elland Road park and ride, delivered in partnership with WYCA, is already proving very popular, and given the demand the car park is now being extended. A further Park and Ride will open at Temple Green in the Aire Valley Enterprise Zone early next year with construction starting in September. As a Council we have pressed for greater local control of rail services as is now reflected in the Rail North and the new Northern and Trans Pennine franchises which will provide for greater growth and new trains. The southern entrance to Leeds Station opened earlier this year supports our ambition to double the size of the City Centre by regenerating the Southbank. The new station at Kirkstall Forge has opened providing a new park and rail option, and unlock the development of new homes and jobs. These are just a few of the examples of the schemes already in construction. With significant funding from the West Yorkshire Transport Fund, the Council is also developing a number of new schemes, including the East Leeds Orbital Road, the Leeds Bradford Airport link (LBA)Road and a transformation of the way traffic uses our City Centre.
- 17. With the promise of the additional £173.5m, the Council can now develop plans for further improving transport in Leeds. This plan will be pragmatic, deliverable, and focus on the outcomes the Council is

trying to achieve. In deciding how to best spend the allocation, the Council will need to make decisions between investing in schemes that can be delivered in the short and medium term, such as park and ride sites, high quality fast bus routes, new rail stations, better public spaces and cycle and walking routes. And plans for long-term projects, which would enable us to provide more capacity to cater for the growing number of trips.

18. The Council recognizes that decisions on priorities will be needed given our limited road space and our constrained rail network. Successfully balancing the conflicting and complex demands on our land use and road space across different stakeholder groups will be a major challenge for the city. The Council intends to develop the plans in collaboration with the City so that these decisions can be owned, understood and supported as it is only with strong support that successful schemes will be delivered.

Corporate considerations

a. Equality and diversity / cohesion and integration

Improving public transport, will improve local connectivity and in turn increases access to employment, education, and leisure services and facilities for all equality groups. The Transport Conversation will be attending a number of different equality group meetings and directly engaging with these groups. Any specific impacts on equality characteristics will be examined in individual schemes.

b. Council policies and city priorities

The anticipated benefits for Leeds from the Transport Strategy development and conversation have the potential to contribute to the vision for Leeds 2030 to be the best city in the UK. Including the following Best Council objectives; promoting sustainable and inclusive economic growth, supporting communities and tackling poverty, building a child friendly city and contribute to the Councils cross cutting 'World-class events and a vibrant city center that all can benefit from' Breakthrough Project.' The vision also contributes to the objectives of the Local Development Framework, Leeds Core Strategy, and Local Transport Plan 3, emerging WYCA Transport and Bus strategies and Strategic Economic Plan.

Conclusion

- 19. The cancellation of NGT has opened up the opportunity for the City to discuss the future strategic transport provision for the City both in the shorter and longer term. The first phase is of necessity, needing to be concluded by October to help ensure confirmation of the £173 million funding promised by the Government. However the conversation will continue to develop into a longer term consultation into the Spring/Summer of next year.
- 20. A presentation at the meeting will summarise some of the key themes along with the wider regional context and some emerging options for the transport programme as the basis for dialogue and feedback from Community Committee members and further input from the local community.
- 21. Members are encouraged to support the Transport Conversation in the local communities and to let officers know of community networks who may be interested in engaging in the Conversation

Recommendations

- 22. To note the wider strategic context of the Transport Conversation which will extend beyond a first phase conversation into the Spring/ Summer of next year, informing a wider transport strategy for the City and your area over the next 20 years
- 23. To note the Department of Transport £173.5 million offer for public transport improvements, in the context of a currently planned report to Executive Board on the 19th October and the planned submission of strategic investment case to the Department of Transport.
- 24. To provide feedback and advise on your key priorities for transport investment in the city and the local community.

Background information

- 1. Each Community Committee has been allocated a Wellbeing Budget which it is responsible for administering. The aim of this budget is to support the social, economic and environmental wellbeing of the area by using the funding to support projects that contribute towards the delivery of local priorities.
- 2. Wellbeing funding cannot be paid retrospectively. An application form must be submitted and approved by the Community Committee before activities or items being purchased through Wellbeing funding are completed or purchased.

- 3. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit, requires the deadline for receipt of completed application to be at least five weeks prior to any Community Committee.
- 4. Some applications will be approved via Delegated Decision Notice following consultation with Members outside of the Community Committee cycle.

Main issues

Wellbeing Budget Position 2015/16

- 5. The revenue budget approved by Executive Board for 2016/17 is £165,140. £71,844.45 has been brought forward from 2015/16 well being allocation which includes any underspend from projects completed in 2015/16 and balance unallocated to projects. The total amount of revenue funding available to the Community Committee for 2016/17 is therefore £236,984.45. Table 1 shows the available well being budget per ward.
- 6. It is possible that some of the projects may not use their allocated spend. This could be for several reasons including the project no longer going ahead, the project not taking place within the dates specified in the funding agreement or failure to submit monitoring reports. Due to this the final revenue balance may be greater than the amount specified. The final carry forward figure from 2016/17 will be finalised with central finance and reported to a future Community Committee.
- 7. The Community Committee is asked to note that £93,096.24 has been allocated from the 2016/17 Wellbeing Revenue Budget. Table 1 shows a remaining balance overall balance for projects in 2016/17 is £143,888.21

Youth Activities Fund Delegation 2016/17

- 8. As a result of a Youth Review agreed in March 2013, an activities fund has been made available to provide local activity for children and young people age 8-17 years across the city. The Activities Fund has been delegated to Community Committees and the allocation to Inner South Community Committee for 2016/17 is £44,620. £4995.81 was carried forward from 2015/16, giving a total available fund for 2016/17 of £49,888.81.
- 9. The Community Committee is asked to note that £43,780.42 has been allocated from the 2016/17 Youth Activities Fund as listed in **Table 2** and there is a remaining balance of £11,341.13. £8,785.00 from Beeston and Holbeck has been ringfenced to be spent in Cottingley.

South Bank Regeneration Framework

Purpose of report

- 1. This paper includes information on the South Bank regeneration proposals. It also sets out details of a three month public consultation on a 'regeneration framework' which includes a number of proposals to regenerate the entire area.
- 2. This report seeks Community Committee comments on proposals and seeks guidance on how best to promote, consult and get the views of residents and businesses from across the area. The draft proposals are available view at www.southbankleeds.co.uk/shapeyourcity or http://democracy.leeds.gov.uk/documents/s148357/South%20Bank%20Report%20Appe ndix%201%20180716.pdf

Main issues

South Bank: What is it?

- 3. The term South Bank is used to refer to a number of activities and investments to regenerate approximately 185 hectares (equivalent to 250 football pitches in size) of land that lies South of the River Aire.
- 4. This includes land in Holbeck (including the area that was but is no longer referred to as 'Holbeck Urban Village') extending to Hunslet Mill.

- 5. Unlike many regeneration projects, there is no set boundary for where the 'South Bank' is, as the aim is to ensure the benefits and investments go beyond any line drawn on a plan and to widen where opportunities may be.
- 6. The area has seen a number of new developments in recent years, including the new educational facilities: the College of Building, Leeds City College, University Technical College, and Ruth Gorse Academy. This has been complemented by the opening of the Leeds Station Southern Entrance, and opening of the Tetley as an Art Gallery.
- 7. Much of the land that will potentially be changed, is vacant, cleared or includes vacant buildings. The roads in particular are an area of major focus. This area where there is a focused look is very close to more populated parts of Holbeck, Beeston and Hunslet.
- 8. However, there remains challenges of ensuring that communities of Holbeck, Beeston and Hunslet benefit from the changes. There remains major physical barriers namely through the road network that dominates the South Bank area currently that disconnects residents and communities from the growing city centre, and the social and economic opportunities that arise.

What are the regeneration ideas?

- 9. A South Bank regeneration framework has been published. This sets out ideas and proposals to regenerate the area. The focus of the plan is mainly on the infrastructure needed to develop, change and improve the place.
- 10. The vision is to extend the city centre by doubling it in size and create 35,000 jobs and over 4,000 new homes. The framework also sets out how the HS2 station will integrate into the city. The HS2 station will join with the existing station to create a transport facility that will be busier than Gatwick Airport currently is.
- 11. A priority in the framework is to better connect surrounding neighbourhoods to the area. The plan will, once agreed, inform and shape formal Council policies for investments and decisions by developers, investors and Council activities.
- 12. The ideas include projects that could be major and bring major change for many residents and businesses. Some of the headline ideas in the framework include
 - Maximising the River Aire and surrounding areas as a major leisure, events and recreation space for people of all ages to engage with.
 - Creation of six pieces of public open space as well as areas for events, play and animation. These would include a forecourt for HS2.
 - Transformation of the road network in the South Bank to be more pedestrian and cycle-friendly through a 'city boulevard' design. This will see more tree planting and wider pavements next to roads, lanes of traffic removed and traffic speeds calmed.
 - New routes from the South Bank to adjoining neighbourhoods to improve connectivity, and land uses to support the creation of a range of employment opportunities.

- A vision for the redeveloped Leeds Station to include HS2 maximising the opportunities of high-speed rail through an architectural statement reflecting the city.
 It also offers the chance to transform the areas around the station as a major destination and also to create a new commercial zone of international significance.
- The creation of a city centre 'green park' to serve the area and the wider city.
- Vision of an area with a mixture of uses, with land uses for commercial development, residential and housing, community facilities and education.
- Nurturing the growth of independent food, beverage and retail in the area.
- Potential for landmark, taller buildings and major leisure destinations to be developed at a set location.
- Innovative ways of protecting the area from flood risks including channelling and urban forests.

Consultation

- 13. A three month public consultation has started on the regeneration framework. At this stage, many ideas in the framework are at a high level and subject to more work on delivery.
- 14. Ideas such as the park have little detail at the moment as the views of the public are sought to refine and define what the city park should be like.
- 15. We also want to get a sense of what the challenges in the short term are, to ensure that the framework responds to the concerns and ideas that people have.
- 16. This means that there is a real chance for people to influence and shape what happens next in the area at an early stage.
- 17. It is essential that the South Bank proposals link with the surrounding communities. A priority is to get views of communities living in and near to the area being looked at
- 18. The consultation aims to get the ideas and thoughts from as many people from Inner South Leeds so they can influence and inform the plan, and to ensure the right solutions are found in the area and to better connect the areas to the planned economic growth.
- 19. There will be a roadshow of consultation events including drop ins, and workshops. Drop in sessions have been booked at St Matthews Community Centre, Hamara Centre, Dewsbury Road one stop centre, Hunslet Club and presentations will be made to residents associations. The exhibition stand will be there at Breeze events in Holbeck, Beeston and Hunslet. A workshop is planned for the next Neighbourhood Improvement Board.
- 20. Views can be given through the completion of an online questionnaire, e-mail, paper questionnaires with pre-paid envelopes, and the completion of suggestion cards

Options

21. This paper is presented to seek the views of Members on both the draft ideas but also how officers should best promote and engage residents on the draft plans. The consultation approach is adaptable and there is flexibility in how the consultation happens with residents.

Conclusion

22. The draft proposals for South Bank will be transformational for the city once delivered. It is a major priority to ensure South Bank proposals link with the surrounding communities. A priority is to get views of communities living in and near to the area being looked at so the views of local communities inform the final version of the plans.

Recommendations

23. Inner South Community Committee is asked to provide its thoughts on the draft South Bank plans and give steer as to how the best to promote the ideas and engage local residents and businesses on the draft proposals.

Community Safety Update Report

Purpose of report

The purpose of this report is to provide Members with information on reported crime figures and anti social behaviour over the period 1st April 2015 and 31st March 2016.

Main issues

- 1. Appendix 1 provides crime data for the period 1st April 2015 31st March 2016 and shows an upward trend for most offences. This increase is replicated across Leeds and across the force area and can be attributed to two Home Office recording changes introduced which have required that offences are recorded based on the victims perception and houses in multiple occupation with more than one household are now recorded as separate offences. (for example if a burglary offence occurs in a house of multiple occupation with 4 occupants who each have a bedroom, 4 burglary offences would be recorded).
- 2. Members will be aware that multi agency tasking arrangements were introduced in 2014, since that time Members have been invited to tasking to raise any concerns or issues from constituents and members of the community. These arrangements have received positive reviews and allow partner agencies to deal effectively with issues before they escalate and ensure Members are kept up to date and reassured of the action taken to address community concerns.
- 3. The Change in Home Office recording standards has particularly impacted on violent crime figures as this is now victim perception based, low level incidents such as pushing that may not have been recorded previously are now reflected in the figures.

- 4. During the last eight months policing in Leeds has seen a great deal of change with the implementation of the new operating model. The old NPT was replaced with the Inner South Partnership Working Area, a team which consists of Ward Officers and PCSO's. We are currently stretched due to low staffing levels but continue to investigate crime, problem solve and proactively patrol to tackle crime and to safeguard our communities. There is currently a recruiting drive for both PCSO's and PC's.
- 5. Despite the figures produced by Safer Leeds showing an increase in offences over the eighteen month period, it is worth pointing out that in recent months, serious and acquisitive crime offences have actually decreased across all three wards of the Inner South. This is mainly due to the arrests and charge of several very active offenders who have been given custodial sentences following them being identified as being responsible for numerous vehicle crimes.
- 6. We have executed several drugs warrants from which we have recovered drugs and paraphernalia and charged those responsible. We continue to obtain and develop intelligence, assisted by our partners, and have had convictions for cultivation and supply. We have taken part in the 'Walkabout' days along with LCC colleagues and others in an attempt to reassure the residents in those areas.
- 7. We are still committed to patrolling Holbeck daily as a part of the Managed Approach to Sex Working and enforcement action around offences of public indecency and soliciting have increased.
- 8. Two Op Champion days of action have taken place during the last few months firstly at Beeston and then in the Middleton area. This was a joint operation between the police, VOSA and Customs and Excise departments targeting vehicles which are not fit for purpose for a number of reasons. Numerous vehicles were stopped and tested for the correct fuel and to make sure the vehicles were safe to be on the roads. The police deployed the pro laser speed device in the area as well as a vehicle fitted with an ANPR camera. Several offences were identified. The next one is currently being planned to take place in Hunslet next month.
- 9. The Leeds Off Road Motorcycle team are working closely with LCC Parks, especially in the Middleton area, in order to identify and seize those off road bikes which are causing ASB and pose a threat to other motorists, and have issued warnings to riders and seized several bikes. They have also set up the 'Bumpy' scheme to provide youths with legal and legitimate supervised access to motorbikes and discourage illegal use."

10. The table at Appendix 2 shows a breakdown of the 217 cases investigated in the Inner South area during 2015/16. All anti-social behaviour (ASB) cases are managed within the team from 'reporting to outcome, and ASB caseworkers cover areas by Leeds City Council Wards. The team works closely with a range of agencies to tackle ASB, provide support, and improve community safety across all tenure types. The team also covers the City Centre, and works with agencies to tackle asb issues such as begging and street drinking. During the last year the processes for tackling noise nuisance have become firmly embedded within the Leeds Anti Social Behaviour Team (LASBT). Officers have been trained to witness noise nuisance, install noise monitoring equipment, and are working closely with the Out of Hours Noise service, to ensure that noise issues are dealt with in a joined up way.

City & Hunslet Ward

11. The team continue to work with a range of agencies to tackle the issues around begging in the city centre. Those involved in this activity present with complex support needs, and high levels of vulnerability. A key aspect of this work is multi agency engagement with support and outreach services to try and encourage those involved in asb to engage with services. If there is no engagement with services, and begging continues these cases are escalated to a multi-agency Strategy and Enforcement Group for discussion and agreement on the best course of action to stop the behaviour.

Beeston & Holbeck Ward

- 12. During the year the team have undertaken concentrated work within Meynell Heights, following an increase of asb reports from residents. Problems reported were around drug dealing, people sleeping rough and taking drugs in the communal areas, rowdy behaviour, threats, and properties being used for sex work. Joined up work with police, housing and other agencies was met with a number of successes within a two week period. The team obtained a Premises Closure Order for one property, further work with a private landlord led to a drug dealer being evicted. A vulnerable tenant being preyed on by sex workers was re-housed at his request. And an Injunction was taken out against a highly volatile drug user who was using the communal areas to take drugs and sleep in. Since this action was taken complaints have reduced.
- 13. The other area of focus is youth nuisance in the Cardinal, Parkwood, and Waincliffes. The team continue to work closely with housing, police, youth services, youth offending and support services to tackle the asb/criminal activity in the area. Where the youths are linked to tenancies, action has been taken against the tenants of these properties. In cases where support has failed and asb behaviour continues, the use of Anti-social Behaviour Injunctions and Criminal Behaviour Orders is explored.

Middleton Park Ward

14. As the 'case type' statistics above show, Hate Crime reports are the highest in this ward area. Work continues to encourage reporting and tackling this problem. The

team are actively involved in the ongoing Hate Crime operation in this area, and take part in a range of action days. Where there is evidence of Hate Crime a zero tolerance approach is taken. ASB case officers have close links with the Hate Crime Co-ordinator for the area, and refer Hate Crime cases in to, and are part of the Hate Crime Multi Agency Risk Assessment Conference, chaired by Safer Leeds.

15. A further area of concern is speeding cars and motorbikes. The Team as attended meetings with agencies to explore ways of identifying those involved in this dangerous behaviour. If policing teams identify those involved, they will refer the details into the team. The team will visit those involved to warn them of action that could be taken if we have evidence speeding/causing nuisance around the estate.

Customer Satisfaction

- 16. Customer Satisfaction Surveys are undertaken and feedback from customers is one of the most important measures of what's gone well, and what needs to be done to improve the service for future. All outcomes from Customer Surveys is shared with the team to enable learning, and the sharing of good practice.
- 17. During 2015/6 customers in 274 cases were asked to complete surveys. 183 customers completed them, providing a high response rate of 66.8%. The table below shows the feedback from customers against each of the questions asked in the survey. It is pleasing that customer satisfaction remains high against all measures.

Conclusion

18. Due to the changes in Home Office recording changes it is difficult to make comparisons with the previous year and draw accurate conclusions.

Recommendations

Background information

It should be noted that there are a number of factors which impact on crime; these can be placed in 3 broad categories:

- A suitable target or opportunity high value items which can be removed relatively easily, vulnerable premises or people, unlocked doors or windows, etc.
- A motivated offender someone whose values or beliefs make stealing / violence acceptable, drug dependency, someone motivated by greed, etc.
- A low likelihood of getting caught no police or security patrols, a
 neighbourhood with a culture of low reporting of crime, no natural street
 surveillance, properties obscured by overgrown bushes, etc.

The work undertaken by the multi agency partnership through tasking seeks to address these vulnerabilities to reduce crime. This maybe through awareness campaigns to ask drivers to keep valuables out of sight, advising householders to cut back hedges or through visits to potential offenders.

Inner South Community Committee Update Report

Purpose of report

1. To bring to Members' attention, a summary of work which the Communities Team are engaged in based on priorities identified by the Community Committee, that are not covered elsewhere on this agenda. It provides opportunities for further questioning or the opportunity to request a more detailed report on a particular issue.

Background information

2. The Community Committee has a Community Plan that is updated throughout the year where actions are detailed against the Community Committee priorities. This report provides regular updates on some of the key activities between Community Committee meetings including project work, community engagement, partnership work, functions delegated to Community Committee, Community Champions roles and actions, integrated working and locality working.

Main issues

- 3.0 Updates by theme: Children's Services, Community Champion: Cllr Angela Gabriel
- 3.1 Children & Families Sub Group
- 3.1.1 The Children & Families sub group has not met since the last meeting of Community Committee. The primary function of this group is to consider and approve Youth Activities Fund (YAF) applications. As the funding has been fully allocated there has been no need to meet.

3.1.2 The Communities Team and Children's Champion are currently considering the future purpose and need for this sub-group beyond the allocation of YAF.

4.0 Updates by Theme: Employment, Skills & Welfare, Community Champion: Cllr Kim Groves

- 4.1 Employment, Skills and Welfare Board
- 4.1.1 The most recent meeting was on the 2nd of June with the focus of the meeting being Community Led Local Development (CLLD) and the consultation that will be held across the Inner South over coming months. This European Funding will provide support to local people through agreed projects to make them 'work ready' for future opportunities.
- 4.1.2 Going forward it has been decided that future meetings will be themed. The theme for the next meeting, which will be held on the 21st of September 2016, is supporting young people. Main agenda items include:
 - Action Tracker from Community Committee workshop on young people
 - Children's Services role and NEETs/What work has been commissioned in South Leeds and how is this being delivered
 - IAG in Schools/providing more opportunities for work experience
 - An example of a local project and the work being delivered Hamara
 - Connecting people to skills in South Leeds/working with business
- 4.1.3 The Employment & Skills Action Plan includes an action around engaging better with local businesses. Earlier this year a meeting was held with DePuys and a meeting with Symingtons is planned for Autumn 2016.
- 4.2 South Leeds Debt Forum
- 4.2.1 After the workshop with voluntary, community, third sector and council colleagues in April re-establishing the forum, the second meeting took place in June and included a presentation of the main points from the workshop. These included:
 - Networking and sharing information
 - Linking into local/national campaigns e.g. illegal money lending
 - Making the service local by consulting with local people
 - Breaking the cycle, prevention and tackling stigma
- 4.2.2 In addition, work will focus on savings and good sources of credit through organisations such as Leeds Credit Union. A services matrix will be uploaded to the South East Debt Forum Facebook page, which partners, colleagues and elected members will be able to access.
- 4.2.3. The Third Sector Leeds Goes Local event was held in June and focused on the impact of austerity measures on local communities. Presentations from Christians

Against Poverty (CAP), Citizens Advice and Green Doctor were informative and well received. After reviewing the feedback the SE Debt Forum action plan will include:

- older people and debt (often following a bereavement); and
- mental health issues around debt leading to substance/alcohol abuse.

5.0 Updates by theme: Environment, Community Champion: Cllr Adam Ogilvie

- 5.1 Inner South Environmental Sub Group
- 5.1.1 The most recent meeting of Inner South Environmental Sub Group was held on the 8th of June 2016 with the meeting have discussions on the following issues:

Holbeck Landlords Forum. Between 15 and 20 landlords attended the most recent meeting. It was reported that 49 long term properties have been brought back into use out of a possible 72. The first area of the Leeds Neighbourhood Approach in Holbeck has now been completed with the second area scheduled to start soon.

The bin yard project is ongoing and analysis is being done to look at the cost effectiveness of the scheme; currently it's running at £20,000 per 5 properties.

Dog fouling: Discussions were held around the potential for introducing new responsibilities for dog walkers and them having to carry 'doggy bags'. Daventry Council have introduced this by law as part of its approach to dealing with the problem of dog fouling.

Cottingley: Services on the Cottingley Estate are currently being reviewed with a small number of households in Cottingley still on black bag collections (approx 200). All properties that still have the bag collection have "multiple stepped access" so there is no availability for bins to be provided. There is the possibility of looking at bin storage facilities (communal bins) but this has created issues in the past with fly tipping in other parts of the city.

6.0 Update by theme: Community Safety, Community Champion Cllr Mohammed Iqbal

- 6.1 Locality Safety Partnership
- 6.1.1 The next meeting of the South East Locality Safety Partnership will be held on the 8th of September 2016 at Elland Road Police Station.
- 6.2 Leeds Managed Approach to Street Sex Working
- 6.2.1 Following the recent public consultation concerning the managed approach and based upon both the evidence and the consultation, Safer Leeds has decided to support a revised approach. This will balance support for a core group of vulnerable sex workers, who will continue to be allowed to operate within the rules, with a targeted approach to enforcement focussing on those drawn into the area, together with a robust approach to breaches and criminality.
- 6.2.2 A detailed plan will now be drawn up but key features of the response will include:

- Adjustments to the hours of operation to reflect the impact on businesses
- Potential adjustments to the geography to protect businesses affected
- Commissioning of support services to enable women to exit sex work over the medium term
- Implementation of a tactical enforcement plan to counter those drawn into the area
- 6.2.3 As with all strategies Safer Leeds Executive will keep this under constant review and will adapt as necessary to respond to any changes in circumstances.

7.0 Updates by theme: Health and Wellbeing, Community Champion: Cllr Paul Truswell

- 7.1 <u>Leeds Health and Wellbeing Forum</u>
- 7.1.1 The last Forum meeting was held on 13th July 2016 and included presentations from both Leeds South and East CCG and Leeds West CCG. The aim was for the organisations to present their operational plans for the area and then for those attending to have a chance to discuss and ask questions linked to these plans. The main questions were related to GP shortages, access and capacity for appointments. More in depth discussions followed to highlight the issues the CCG faces especially around GP shortages. Within the session the CCG's General Practice Strategy was highlighted which looks to tackle some of the issues discussed.

7.2 LSE CCG Social Prescribing – Connect for Health

- 7.2.1 Connect for Health and the Health Trainer Service continue to offer 1:1 sessions in a variety of Inner South venues, both services aim to support local people to improve their overall health and wellbeing. To date there have been 660 referrals and the main gap that has been identified is a befriending service for people experiencing social isolation. In addition Connect for Health have been working with the other Social Prescribing services across the city to ensure that 'there is no wrong front door in Leeds'.
- 7.2.2 There are still some GP surgeries that are not sending referrals to the service. It has been agreed that partners, especially Housing, would promote the service as widely as possible and that a session would be held with housing staff to provide information on the project.
- 7.3 Leeds South and East reducing smoking prevalence rates
- 7.3.1 There was a launch of the 'Today is the Day' campaign at the South East Health and Wellbeing Forum on 13th July 2016. The Forum event started with a presentation on the campaign and there were promotional materials for people to take away. The

- campaign aims to encourage people to make a quit attempt by engaging with Leeds Smoking Services and uses local resident's stories to highlight the benefits of stopping smoking and using the service to support the process.
- 7.3.2 Resources have been provided to support the Stop Smoking Incentive scheme. The scheme aims to support pregnant women to stop smoking by offering a £100 incentive to engage with Leeds Smoking Services. The scheme is due to start in August 2016 and will be piloted by the midwife at Lingwell Croft Surgery.
- 7.4 Cottingley Health and Wellbeing Sub Group
- 7.4.1 The final date for the Community Consultation was on the 31st May 2016 and out of 1100 questionnaires sent out 80 responses were received. The main cause for concern on the estate was anti-social behaviour and in a response to this a meeting was held to bring together all relevant agencies to look at actions that could be taken. There is currently a pop up service at Cottingley Community Centre which is run by Leeds City Council Customer Service Officers and we have been able to add additional agencies to this service to meet the community's needs. Along with the Customer Service team there is now representation from Connect for Health, Money Buddies. PCSO's and the Anti-Social Behaviour Team.
- 7.5 Middleton and Belle Isle Health and Wellbeing Sub Group
- 7.5.1 Work identified though the sub group has led to an offer of two bespoke mental health training sessions for frontline staff. The sessions are being offered in September at BITMO Gate and Beeston Village Community Centre.
- 7.6 Best Start
- 7.6.1 An initial database of services has been produced and will be updated and redistributed every 2 months to steering group members. Training opportunities are also being identified and offered to steering group members, such as restorative practice training and a presentation on baby week which included activities that are taking place and how people could get involved. A specialist programme facilitator at Health for All has attended baby massage training and will be offering sessions free of charge. A social media page has been set up with local parents to promote services and events available to families with children aged 0-2 in South Leeds South Leeds Baby and Toddler Network
- 8.0 Updates by theme: Adult Social Care, Community Champion: Cllr Patrick Davey
- 8.1 Community Committee Neighbourhood Teams Update
- 8.1.1 At the 15th June Community Committee, Members received a report on the Integrated Health & Adult Social care neighbourhood teams. Based on the feedback from the discussion, a plan is being developed which will cover the following areas:

Neighbourhood Team contact

The 13 Neighbourhood Team co-ordinators have been nominated as contacts who will direct any queries / requests on to their ASC / Leeds Community Healthcare colleagues as appropriate. The co-ordinators for the Inner South area are Michelle Thompson, based at Beeston Hill Community Health Centre, and Karen Williams, based at Middleton Community Health Centre. The full contact list is attached as **appendix 1**.

Request for numbers of patients currently on the 2% list

This enhanced service is designed to help reduce avoidable unplanned admissions by improving services for vulnerable patients and those with complex physical or mental health needs, who are at high risk of hospital admission or re-admission. Each GP practice manages 2% of their vulnerable patients or those at high risk of hospital admission.

How to refer people receiving care within the Health and Social Care system Work is continuing on development of a high level communication around citywide transformation, involving people taking more responsibility for their own health (#withyoualltheway).

Neighbourhood Team Geographical boundaries

Neighbourhood teams are aligned to GP practice populations and therefore do not work to geographical boundaries. A map showing which wards fall within which Neighbourhood Team areas is included at *Appendix* 2.

Further, more specific detail on the particular cross boundary issues are being obtained from ward members which determine the most appropriate escalation route.

9.0 Integrated Locality working

- 9.1 <u>Neighbourhood Improvement Boards(NIBs)</u>
- 9.1.1 The next meetings of the City & Hunslet and Belle Isle & Middleton NIBs will be held on the 13th and 27th of September respectively. At the time of writing this report the date for Beeston & Holbeck was still to be agreed. However there is work ongoing in Cottingley and the Communities Team are establishing at Holbeck Forum.
- 9.1.2 The Belle Isle & Middleton NIB last met on the 12th of July 2016. The main issues discussed at the meeting included:
 - Social prescribing
 - Middleton Park Health & Well Being Partnership
 - Community Engagement (Love where you live project)
 - Community Led Local Development

Inner South Community Committee Plan – Priorities and Actions, Engagement Framework and ward profiles 2016/17

Purpose of report

1. The report presents the Priorities and Actions, Engagement Framework and ward profiles for 2016/17.

Background information

- 1. The Best Council Plan 2015-20 outlines the city wide priorities for Leeds and sets out a number of breakthrough projects it will focus on in 2016/17. The Inner South Community Committee Plan underpins the council's citywide ambition for a strong economy and a compassionate city and demonstrates how it will contribute to the priorities and breakthrough projects.
- 2. The priorities and actions plan sets out the local priorities to tackle poverty and reduce inequalities, whilst delivering effective and efficient services, which meet the needs of the people in the area. The Engagement Framework details how we will consult with local people to ensure they have a say in the decisions that are taken about their area.
- 3. The ward profiles contribute to the plan by providing key data on deprivation and demographics.

Main issues

4. The Priorities and Actions plan (**Appendix 1**) sets out the local priorities to tackle poverty and reduce inequalities, whilst delivering effective and efficient services, which meet the needs of the people in the area.

- 5. The Engagement Framework (**Appendix 2**) details how we will consult with local people to ensure they have a say in the decisions that are taken about their area.
- 6. The ward profiles (**Appendix 3**) provide a snapshot of the ward and provide key data on deprivation and demographics.
- 7. These papers form part of a suite of documents, which together make up the community plan. Other documents include performance reports from services presented to the community committee throughout the year.
- 8. These local plans underpin the council's citywide ambition for a strong economy and a compassionate city and contribute to the council's breakthrough projects for 2016/17, and in particular:
 - tackling domestic violence and abuse;
 - making Leeds the best place to grown old in;
 - strong communities benefitting from a strong city;
 - more jobs, better jobs; and
 - early intervention and reducing health inequalities. It sets out key priorities supported by Community Committee through its delegated budgets and delegated roles and functions.

Corporate Considerations

9. The Community Plan incorporates the community engagement framework for Inner South Community Committee that has previously been approved.

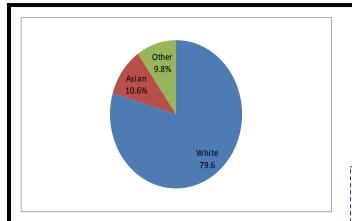

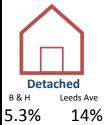

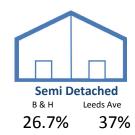

PROJECTS

Holbeck Neighbourhood Plan:

Centred on a pre-industrial village, Holbeck is an inner city area located about 1km southwest of Leeds city centre. It is bounded by Ingram Way to the west, the M621 to the south, Meadow Road to the east and Sweet Street and the railway line to the north. The major road and railway boundaries form significant and well-defined edges to Holbeck which adjoins Holbeck Urban Village lying north of Sweet Street. Part of the Holbeck Neighbourhood Plan area, between the railway and Sweet Street, lies in the South Bank.

New Housing in Holbeck:

In Holbeck, five of the six multi storey blocks have been demolished as part of the Housing PFI scheme.

New homes (houses and flats) for rent have been built on the site previously occupied by the multi-storey blocks. The remaining block has been refurbished by Housing Leeds in partnership with KeepMoat.

Beeston Forum:

The Beeston Community Forum is an organisation which campaigns on behalf of the residents of Beeston.

"Managed Area'/Managed Aproach':

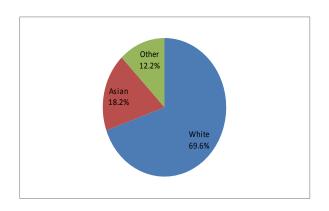
The managed area was introduced in October 2014, originally as a pilot scheme and was extended in 2015. This hopes to tackle the long standing problem of sexworking and soliciting in the area.

Beeston and Holbeck Neighbourhood Improvement Board:

The Improvement Board brings together leaders to drive change and improvement in the wards of Beeston and Holbeck and City and Hunslet so that the area becomes an increasingly attractive and popular place to live.

The team provide effective governance and leadership arrangements that are responsive to the needs and aspirations of local communities, providing better, more responsive and personalised services to citizens.

CITY & HUNSLET WARD



The ward includes a chunk of the city centre, with the remainder mostly residential (with a sizeable industrial area). The ward is fragmented due to a large number of road and rail networks, including the River Aire/M1 and M621.

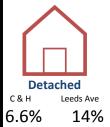
Health:

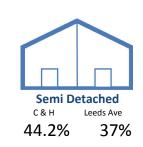
Hunslet Green and Thwaite Gate MSOA has the highest allcause mortality rates for both men and women in the city. Both male and female cancer mortality rates are significantly higher than the city average.

Mortality rates for men linked to both circulatory disease and respiratory disease are significantly higher than the city average.

Housing:

Fewer family homes, many high rise blocks, lots of back to back terraces (Census 2011)

PROJECTS

Socio-economic description of the ward:

There are approximately 33,705 people living in the ward, of which 47.4% are female and 52.6% are male. Overall it is a very deprived area as illustrated by the results of the 'Index of Multiple Deprivation' for the 12 Super Output Areas (SOAs) in the Ward: five are ranked in the lowest 3% in the country, another four areas are in the lowest 10%.

Many of the homes in the Hunslet and West Hunslet areas are provided by Housing Leeds. There is a particular concentration of back to backs in Beeston Hill which are mostly in the private rented sector.

The last census indicates the population by area is White (60.8%) but the ward also has a significant concentration of residents from BME communities (about 39.2%), particularly in the Beeston Hill area.

Development/regeneration plans:

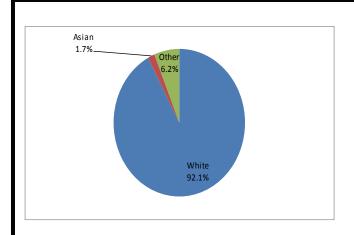
Part of the area is included in the Beeston Hill and Holbeck Housing PFI programme to provide new affordable homes and refurbish others bringing significant housing improvements. The Beverleys area of Beeston Hill (former back to back houses) have been demolished and being redeveloped with new housing.

The Garnets estate: a total of 78 properties were demolished in this area, with current proposal for a 25, 2-3 family houses on a 0.4 hectares site. Council officers are working closely with the Garnets Community Group to ensure they are engaged in the work to regenerate the area. A major part of the Ward is included in the public-private sector Investment Partnership for South Leeds.

Key Successes:

- The Greenhouse private development proving eco friendly apartments/work live spaces.
- Part of the ward is included in the 'Aire Valley Employment Area'.
- The East Leeds Link Road has opened up the area and this should help to generate significant numbers of additional jobs.
- Brickfield Park has been developed on the site of part of the Ladypit Lane allotments, which have also been improved.

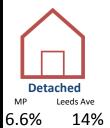

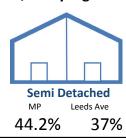
The MSOA of Belle Isle North has the highest smoking prevalence in the city at 38.2%

PROJECTS

'Love where you live '

Engagement in Middleton and Belle Isle is sporadic and has been declining over a period of time. A project has been set up to work with communities and partners in Middleton and Belle Isle to localise projects and build a sense of pride in the area.

Housing in Middleton:

In Belle Isle, about 44% of households are renting from the local authority through Belle Isle Tenant Management Organisation – one of the remaining tenant led and managed housing organisations in Leeds, covering homes in Belle Isle. About 40% of households are owner occupiers.

In relation to Middleton, 47% of households are owner occupiers, with 41% renting from the local authority through Housing Leeds.

About 42% of the homes are semi detached properties with 37% being terraced.

Recent developments:

Partnership work with BITMO has increased over recent years, particularly since 2010 where key priorities regarding services and locality working is being addressed in a collaborative way.

The ASDA Development was delivered in partnership with Employment and Skills and ensured that 90% of local people gained a job working for the supermarket.

Key Successes:

- New ASDA supermarket successfully located in area. A recruitment drive was done locally with a high 90% of jobs awarded to local residents.
- New Forest Village major private sector housing development off Sharp Lane.
- Transform Tenants Hall (Health for All's base) into a Catalyst Centre, as they are a key organisation/stakeholder in the area.
- Middleton Park received investment from Heritage Lottery Fund to create a new visitor centre.
- Middleton Community Hub (identified as a Pathfinder service).
