3 Minutes - 20 March 2018

4 Open Forum

In accordance with the Community Committee Procedure Rules, the Chair allowed a period of up to 10 minutes for members of the public to make representations or ask questions on matters within the terms of reference of the Area Committee. On this occasion there were no members of the public in attendance who wished to make any representations.

Members heard from John Robinson and Ashlie Rossington-Harris of John Smeaton Leisure Centre who were in attendance to inform the Community Committee of their plans to increase their presence in the Outer East Area. It was reported that there was a wide range of sport and physical activities on offer for all age groups and it was aimed to highlight the opportunities for participation to the local community.

Outer East Community Committee Briefing Neighbourhood Teams – September 2018

1. Purpose of report

1.1. This report updates on the progress with Strengths Based Social Care across the city and draws attention to local features of this new approach to service delivery.

2. Strengths Based Social Care (SBSC) Model – An Overview

2.1. The new strengths-based model establishes a way of delivering adult social work practice that is:

- Values driven
- Community focused in achieving outcomes
- Empowering of staff
- A partnership with local people
- Builds on the asset based approach already in place in Leeds

2.2. The new model moves away from the focus on eligibility and assessment towards a strengths-based and person-centred approach.

2.3. With SBSC, the starting point is always to look first at what someone can do rather than what they can't do; a move away from "what's wrong" to "what's strong".

2.4. After an initial conversation with a customer to understand their concerns and see what they have tried already we try to get them to the right place to help them.

2.5. That 'right place' may be a pre-booked conversation with one of the social work team at a local community venue, but it may be some peer support or a community group.

2.6. Social Workers have designed new tools to reduce bureaucracy and enable transparent conversations with customers that focus on the individual and the outcomes they desire.

3. Main issues

3.1. New ways of working

3.1.1. During the initial call customers have more clarity around their options and The What's Out There Guide has been designed to enable call handlers to connect customers to beneficial services in their community.

3.1.2. A Rapid Response team is now in place to stabilise all crisis situations with a focus on make safe, short term work.

3.1.3. Customers can now also book a community appointment with a Social Worker in a Talking Point; the average wait is currently 10 days.

3.1.4. Each Neighbourhood Team has a community-based Talking Point where customers can meet Social Workers and see the range of options open to them in their local area.

3.1.5. At the Talking Point and in place of home visits and lengthy assessments Social Workers and customers can now have a series of conversations based on what the customer wants.

3.1.6. Social Workers have re-designed paperwork to record conversations so it is easier for customers to understand and less bureaucratic to complete.

3.1.7. This also empowers Social Workers to spend more time with customers and understanding their local community.

3.1.8. Teams now meet to 'peer review' their work before submitting support plans and this increases team knowledge and understanding and introduces creative solutions.

3.1.9. New ways of working are being embraced and the approach is being applied across different services within Adults & Health and with our Health partners across the city.

3.2. Local Progress & impact

3.2.1. Customers have told us that it is “nice to just have a conversation” and feedback is being gathered as part of the ongoing evaluation work.

3.2.2. Each NT offers on average 4 TP appointments per week with an average wait time of 10 days.

3.2.3. More people are having their needs met in a way that doesn’t require traditional services but enables them to live life the way they choose.

3.2.3.1. **Kippax Neighbourhood Care Management Team**

3.2.3.2. Social workers have been having better conversations due to the more fitting paperwork.

3.2.3.3. Paperwork is much more proportionate and customers find it easier to understand.

3.2.3.4. Talking points have allowed the team to pick up referrals more quickly and social workers can see more people in a day at Talking Points.

3.2.3.5. Social Workers keep cases for clients at talking points ensuring more continuity of support

3.2.3.6. There has been more linking together of teams, e.g. through staff networks and champions. This has allowed better cooperation between teams.

3.2.3.7. More usage of community venues has led to better signposting and links to activities for customers.

3.2.3.8. **Seacroft Neighbourhood Care Management Team**

3.2.3.9. The team has really appreciated the new paperwork, as it has allowed them to engage in better conversations with customers. By stripping out needless box ticking questions, the conversations keep focused on what the customer really wants to discuss, and helps keep the recording based around that too.

3.2.3.10. Talking points have been really helpful in seeing people more quickly. Customers are put at ease by the community venue, and being in a single location helps social workers to see up to 5 people in a day. The community venue also helps in planning signposting and linking customers in to local activities.

3.2.3.11. Champions from the team have linked in with relevant groups such as the Extra Care group and integrated monthly meetings, to help find creative solutions for individual cases.

3.2.3.12. Peer Review has been set up to help spread knowledge within the team, with social workers being given an opportunity to comment and make suggestions for cases.

4. Conclusion & next steps

4.1.1. Strengths-based Social Care places the customer at the heart of conversations which now involve our community partners.

4.1.2. A quality performance framework is in place to ensure consistency across the city and to monitor the impact from a customer, quality and financial perspective.

4.1.3. The approach is currently being evaluated with the assistance of nationally renowned academic John Bolton and initial findings are due later in the year.

4.1.4. As new ways of working embed the approach is being explored with providers and partners across the city.

5. Recommendations

5.1. That Elected Members note the above update.

5.2. That Elected Members note the desire to return to the Community Committee Chairs Forum with a summary of this round of updates.

5.3. That Elected Members consider how we further build relationships between Adults and Health and local communities and benefit from Members' expert local knowledge.

Outer East Community Committee Delegated Budgets Report

Purpose of report

1. This report seeks to provide Members with:
 - a) An update on the outer east budget position
 - b) An update on the Wellbeing revenue projects and budget position (Table 1)
 - c) An update on Youth Activities Fund projects and budget position (Table 2)
 - d) An update on the Wellbeing capital projects and budget position (Table 3)
 - e) An update on the Community Infrastructure Levy (CIL) Neighbourhood Fund (paragraphs 27-31)
 - f) Consider that any CIL contributions received are earmarked for spending within the ward / area where they were generated (paragraph 29)
 - g) An update on the Small Grants Budget position (paragraph 34)
 - h) An update the Community Skips Budget position (paragraph 35)

Background information

2. Each Community Committee has been allocated a Wellbeing Budget (revenue and capital) and Youth Activities Fund which it is responsible for administering. The aim of these budgets is to support social, economic and environmental wellbeing of the area and provide a range of activities for children and young people, by using the funding to support projects that contribute towards the delivery of local priorities.
3. Delegated budgets cannot be approved retrospectively. An application form must be submitted and approved by the Community Committee before activities are completed or items / services are purchased.
4. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit, requires the deadline for receipt of

completed application to be at least five weeks prior to any Community Committee. Some applications will be approved via Delegated Decision Notice following consultation with Members outside of the Community Committee cycle.

5. Members are reminded that the Wellbeing Fund Large Grant programme supports the social, economic and environmental wellbeing of a Community Committee area by funding projects that contribute towards the delivery of local priorities. A group applying to the Wellbeing fund must fulfil various eligibility criteria including evidencing appropriate management arrangements and finance controls are in place; have relevant policies to comply with legislation and best practice e.g. safeguarding and equal opportunities; and be unable to cover the costs of the project from other funds.
6. Members are reminded that projects eligible for funding could be community events; environmental improvements; crime prevention initiatives or opportunities for sport and healthy activities for all ages. In line with the Equality Act 2010 projects funded at public expense should provide services to citizens irrespective of their religion, gender, marital status, race, ethnic origin, age, sexual orientation or disability; the fund cannot be used to support an organisation's regular business running costs; it cannot fund projects promoting political or religious viewpoints to the exclusion of others; projects must represent good value for money and follow Leeds City Council Financial Regulations and the Council's Spending Money Wisely policy; applications should provide, where possible, three quotes for any works planned and demonstrate how the cost of the project is relative to the scale of beneficiaries; the fund cannot support projects which directly result in the business interests of any members of the organisation making a profit.
7. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of Wellbeing and Youth Activity budgets, and also regarding the use of the Community Infrastructure Levy (CIL) Neighbourhood Fund which has been allocated to the Committee. Concurrently with the Committee, designated officers have delegated authority from the Director of Communities and Environment to take such decisions.
8. The Committee is invited to review the conditions previously agreed and consider whether any amendments are required, prior to agreeing such conditions for operation in the forthcoming municipal year.

Main issues

Wellbeing Revenue Budget Position 2018/19

9. The revenue budget approved by Executive Board for 2018/19 is **£114,570**.
10. Further to the data in the last Delegated Budgets report, subsequent finance updates have revealed there is an additional £34,196.87 available for projects in the 2018/19 financial year.

11. Table 1 shows a carry forward figure of **£91,618** which includes underspends from projects completed in 2017/18 plus **£42,767.34** allocated to projects which are not yet completed, which means there was £48,850.47 unallocated from the 2017/18 budget. The total amount of revenue funding available to the Community Committee for 2018/19 is therefore **£162,420.87**. Further information of the projects approved or ring-fenced is available on request.
12. **Table 1** shows a projection for current grant applications up to and including 23 August 2018 for consideration by the Community Committee.
13. It is possible that some of the projects in Table 1 may not use their allocated spend. This could be for several reasons including the projects no longer going ahead, the projects not taking place within the dates specified in the funding agreement or failure to submit monitoring and evaluation reports. Due to this, the final revenue balance may be greater than the amount specified.
14. The Community Committee is asked to note that a total of **£120,960** has been allocated from the Wellbeing revenue budget so far this financial year, with **£41,460.87** still available.

Youth Activities Fund position

17. The Youth Activities Fund (YAF) approved by Executive Board for 2018/19 is **£52,010**. Table 2 shows a carry forward figure of £20,264 which includes underspends from projects completed in 2017/18 and £11,902 allocated to projects but not yet completed. The total amount of YAF available to the Community Committee for 2018/19 is therefore **£60,371.90**.
18. Members are reminded that the budget is split by the number of children and young people per ward and is as follows: Cross Gates & Whinmoor 25.8%; Garforth & Swillington 22.9%; Kippax & Methley 25.7%; Temple Newsam 25.6%
19. Applications to Round 1 of the 2018/19 budget came to £51,449.33. Funding Round 2 is currently open for activities taking place between 3 September 2018 and 31 March 2019.
20. It is possible that some of the projects in Table 2 may not use their allocated spend. This could be for several reasons including the projects no longer going ahead, the projects not taking place within the dates specified in the funding agreement or failure to submit monitoring and evaluation reports. Due to this, the final YAF balance may be greater than the amount specified.

Community Infrastructure Levy (CIL) Neighbourhood Fund

27. On 21 October 2015 the Council's Executive Board approved a process for the allocation of CIL in Leeds. Planning applications approved prior to 6 April 2015 did not qualify for a CIL contribution.

28. For each CIL contribution, Leeds City Council retains up to 70-80% centrally, 5% is needed for administration and 15-25% goes to be spent locally. The money will be vested with the local Town or Parish Council if applicable or with the local Community Committee, and spend is decided upon by that body. This local money is known as the 'Neighbourhood Fund' and should be spent on similar projects to the Wellbeing Fund.

29. In Outer East this means that the money for Swillington & Great/Little Preston, and villages in the Kippax & Methley ward go to and will be administered by the respective parish councils, whereas monies for Cross Gates & Whinmoor ward, Garforth town and the Temple Newsam ward will be administered by Communities Team - South East on behalf of the Outer East Community Committee.

- It is recommended that the neighbourhood / ward which generates the CIL should benefit from the money.

30. CIL money is to be considered the same way as Well-being capital funds and should be spent on improvements to local infrastructure. Suggestions for projects are welcomed.

31. The Community Committee is asked to note that as of Dec 2017 there is **£23,174.56** payable to the Outer East Community Committee, with **£15,400.64** currently available to spend. Current / future budgets are broken down as follows:

- Cross Gates & Whinmoor ward has **£11,181.91**
- Garforth has **£4,017.73**
- Temple Newsam ward will have **£7,974.92** when the Cartmell Drive development money is paid

- 3.3 The Council's Employment and Skills service provided a series of information sessions in early September where people were able to hear more about:

The sessions took place at Osmondthorpe One Stop, Kippax Hub, Garforth Hub, Swarcliffe Community Centre, Crossgates Library, Halton Library.

4.0 Updates on Health, Wellbeing and Adult Social Care – Cllr Keith Wakefield

Malnutrition Helpline

- 4.1 Leeds Community Healthcare NHS Trust and Leeds City Council have announced a new initiative aimed at preventing and treating malnutrition in older people.
- 4.2 The malnutrition helpline puts the public and health and social care professionals in touch with a team of dietitians who can provide advice on a range of issues relating to difficulties with eating and drinking. People can access support by calling 0113 843 0905 Monday – Friday, 9am – 4pm or can email the team at lch.malnutrition@nhs.net
- 4.3 Malnutrition is a lack of good nutrition usually caused by not having enough to eat or not getting the essential nutrients you need to keep healthy. If not dealt with early it can lead to other problems. People at risk of malnutrition include; those who are housebound or living alone; those who are not well enough or able to shop for food, cook or prepare meals for themselves; and people with dementia, low mood or mouth/dental problems.
- 4.4 The helpline can support by providing advice for those with concerns about;
- Not eating enough or getting full quickly
 - Poor appetite
 - Losing weight unintentionally or clothes/jewellery looser than normal
 - Constipation
 - Difficulties affording food
 - Dehydration
 - Frail and risk of falls
 - Wounds or a pressure ulcer that won't heal
 - Not well enough to shop or cook
 - Eating difficulties related to dementia
 - Social isolation at meal times

Winter Wellbeing Community Grants Scheme

- 4.5 Leeds Community Foundation (LCF) is running the Winter Wellbeing Community Grants Scheme, with support from Leeds City Council Public Health. The fund will support a range of community-based projects that help vulnerable people in Leeds who are most affected by cold weather. This includes households with young children and pregnant women as well as people with a range of physical/mental health problems, on low income, with disabilities, aged over 65 or otherwise vulnerable.
- 4.6 LCF are looking for innovative ideas that support vulnerable people to prepare for and cope with cold weather and are particularly keen for projects to address social isolation, increase resilience and that help reduce the levels of illness (and deaths) due to vulnerable people living in cold housing. There is a preference to fund practical projects that provide real, tangible help as opposed to purely the onward distribution of information. The fund is particularly interested in new, innovative approaches and projects are expected to link with and actively refer to other services.
- 4.7 Grants of up to £2,500 are available for local community projects and up to £5,000 for citywide projects.
- 4.8 The closing date for applications was on 29 Aug 2018. Applicants will receive the panel's decision by email in the first week of October. Contact the Leeds Community Foundation Grants Team on 0113 242 2426 or grants@leedscf.org.uk for more information

- 5.2 **Environmental update - Cross Gates & Whinmoor / Temple Newsam wards**
- The team have been involved in a clean-up day on the Neville's with colleges from Housing and Probation. The team litter-picked the area and had the path-sweeper and road sweeper in attendance so the whole area was cleansed. Housing provided skips and we took the overspill and helped residents clear their gardens of unwanted items we also assisted with removal of cuttings where Probation had cut back overgrown vegetation.
 - The team cut back a large area behind the properties at Litton Way (Whinmoor) that was vastly overgrown and our colleagues from Parks & Countryside are in the process of weed spraying the area.
 - Ullswater Crescent and Kendal Drive in Halton Moor have had in-depth cleansing after the roads were resurfaced.
 - The team are currently cutting back / litter-picking the ginnels on the Hebdens in Whinmoor.
 - There was a community clean-up on the 15 Sept in and around Manston Park with children from the Tribe youth group and Cllr Grahame.

- We have had two events at Temple Newsam, Cocoon in the Park and Let's Rock Leeds the team made sure the streets in the area were quickly brought back up to standard by litter-picking and emptying litter bins.

- We have been using a lot of CCTV to successfully capture fly tipping within the wards. This has been especially successful in problem areas such as Newsam Green Road. We are looking to use this more often to capture fly tippers in and around the ward area
- We have been helping the various In Bloom groups keep on top of their routes by litter picking, removing waste and sweeping the routes either with a road sweeper (RSC) or a path sweeper
- We have attended to several ginnels around the Garforth & Swillington ward cutting these and clearing the waste away
- A lot of effort has gone into Micklefield the past two months as we have had several enforcement jobs and a lot of street cleansing requested. The team have been litter picking the area and dealing with the various issues as they arise
- The team helped out with Garforth Festival. Providing bags for the waste, tidying up the area before and a deep cleanse after the event. Removing all waste and litter picking the areas

- We have been cutting and clearing many void properties so that tenants can move in and have a manageable garden to attend to, some had years of overgrowth. The team have done very well with the void work as this has recently been brought into the teams and a lot of training was needed. Now they have the training and as they gain experience, they are able to achieve more within a void garden and work better as a team. This as a result produces a much better finished product

6.0 Update on Housing

Outer South East Housing Advisory Panel

6.1 Currently have £24k remaining for 2018/19 from a £54k budget allocation.

6.2 Tenant Engagement Activity

- Neville's new builds – two consultation exercises taken place out in the community successfully engaged with over 50 residents
- Temple Newsam good garden competition – celebration event took place Wednesday 29 Aug at Civic Hall. Excellent feedback from all involved and we will run the competition again next year
- Halliday Court in Garforth
 - Mural completed at the back of the centre with a local artist, residents all got involved to complete the design
 - Completion of new external bin area which will see the current bins that are located inside the block to outside, which will prevent the smell, and infestation of flies and maggots
- White Laithe Court in Whinmoor – another scheme to relocate the bin stores to an outside area to prevent smells/maggots and flies
- Community Payback – 20 referrals received for outer east Leeds six of which have been completed so far resulting in 21 days work completed.

8.0 Update on Youth Service

8.1 Cross Gates & Whinmoor ward

- Youth Matters attended both Swarcliffe and Whinmoor Forums and spoke to councillors and other attendees about their involvement with youth service
- Youth Workers have been working with young people around sexual health & wellbeing – smoking, vaping, staying safe online, Domestic Violence awareness
- Promoted summer programme and distributed publicity around the ward encouraging young people to also share on their social media sites
- Carried out trips with young people
- Young people gained a Leeds Youth Award
- Two very successful activity days at Swarcliffe and Manston – Young people have completed more than two hundred youth activity questionnaires
- The Thursday & Friday youth provisions continue to attract new members each week and they participate in various activities including: dodgeball, football, basketball, tennis, pool, arts & crafts, nail art & beauty, Henna design, music, refreshments and friendship groups
- Youth Workers encourage young people to put their phones away and enjoy healthy activities, make new friends, and engage in voice and influence

8.2 Ongoing:

- Bike maintenance and safety group
- Senior member training
- Youth Matters

- One to one support
- Youth Clubs which are all kept open alongside the summer programme.

8.3 Garforth & Swillington ward and Kippax & Methley ward

- Youth Activity Funded trips out to Flamingo Land, Go Ape at Temple Newsam and Doncaster Dome. Also activity days in Micklefield, Kippax and Swillington. Each of the trips were full and each of the activity days had over 150 young people in attendance at each venue
- The evening provision in each ward also ran throughout the summer which gave young people access to positive activities if they didn't want to access the summer programme
- Had talks with Leeds Utd Foundation, Kippax Leisure Centre and Kippax Parish Council / ward councillors to re-open a youth provision at the leisure centre. These discussions are ongoing but have had a positive response from all parties. We hope to open on a three month trial basis in the middle of September. The session will be on a Monday evening and will be football based. It will be for boys and girls aged 11-18yrs
- The decision making group "YPmyG" (young people my group) have volunteered at the three activity days doing the tuck shop and signing in the attendees. They also made the decision on where to have the activity days and what trips young people would like to go on over this summer. They will be working towards deciding the trips for October half term

8.4 Temple Newsam ward

- Youth Matters Group achieved a Leeds Youth Award and will be attending Civic Hall in October to be presented with certificates
- Supporting young people on the mobile to create CVs and conduct interview techniques
- Working with young people on a range of issues including citizenship / health and wellbeing / sexual health / hopes and aspirations
- KICKS Programme in Halton Moor played a tournament with Burmantofts and won the game, and one young person who accessed this support has now gained employment with JD Sports
- Supported local shopkeepers who were having serious issues with ASB – this has now been resolved
- After issues around ASB at the new Go Ape, youth workers have added this to their list of hotspots and liaise with security there to report any issues to them
- Have received referrals from Temple Newsam Learning Partnership for summer trips.
- Youth workers have for some time been addressing issues around ASB at Colton Sainsbury's and worked hard to divert young people into positive activities and we are pleased to say that there have been no further reports of ASB for some time, this also applies to the fast food outlets in the same area.
- Youth workers have been speaking to young people about the dangers of swimming and diving into rivers during the hot weather

9.0 Debt Forum update

- ### **9.1**
- The Joint Debt Forums Annual Open Meeting took place on 27 Sept 2018 and the title for this year is 'Coming Together'.

- 9.2 The event was themed around universal credit – with presentations covering: what support is already available, what could the Third Sector could offer, responses from advisory services / credit unions, financial education in schools and much more. There was also an opportunity to participate in discussion groups, led by relevant facilitators.

10.0 Community engagement

Social media

- 10.1 Highlights of the Outer East Community Committee Facebook activity from 19 May 2018 – 7 Sept 2018 is included in **Appendix 1**. It gives details of the top three most popular posts ('post clicks' to expand the text + 'reactions, comments or shares') during this period.

Two things to note:

- 'Reach' is the number of people the post was delivered to
- 'Engagement' is number of reactions, comments or shares. Engagement is a better marker for seeing if people are interested in the posts because they need to interact with it. Eg a post might reach 1,000 people but if they all scroll past and don't read/expand it, the engagement level is zero.

Whilst still leading the way, the page has gained a further 81 new page 'likes' in the last 12 weeks and currently has 2,140 followers, which is 222% more than the next most popular Community Committee page.
